In default earnest money shall stand forfeited to the municipality.
8. Security money @10% (inclusive of earnest money) on the tender value shall be deducted from the bill for due performance of works and the same will be released after completion of work in all respects and on expiry of the schedule time limit.

The item of works contained in the schedule shall be executed strictly according to the specification prescribed in KMDA,PWD,PHE schedule and the workmanship may be inspected by competent authority and the contractor shall be liable to make necessary arrangement of facility such inspection.
