Quotation will be opened on the same day at 3 p.m.

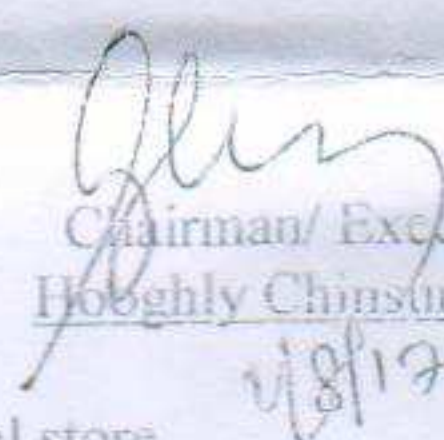
Questioners or their authorized representatives may remain present at the time of opening of Quotation at the chamber of the Finance officer.

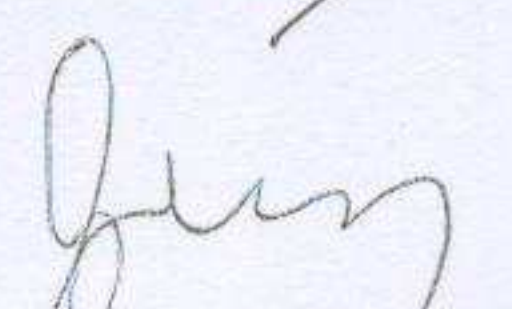
