

2. Sanctioned estimates,. Schedule of works and other terms and conditions may be seen from the Engineering Department at any working days between 2.00 and 4.00 pm except Saturday.
3. Tender is to quote in figure as well as in wards his rated at per or with percentage below to above the estimated cost.
4. The tender document should bear the signatures of the contractors and deposit of earnest money as specified below against in each work is found compulsory and the same shall be deposited in each with the municipal cashier prior to submit tenders, if deprives, the tenderers may deposit Demand Draft on any scheduled Indian Bank,
5. The successful tenderers shall have to execute agreement with the municipality on non judicial stamp paper at his own cost within 4 days from the date of receipt of the letter confirming acceptance of tender and shall commence work as per direction contained therein; in default earnest money shall stand forfeited to the municipality.
6. Security money @10% (inclusive of earnest money) on the tender value shall be deducted from the bill for due performance of works and the same will be released after completion of work in all respect and no expiry of the scheduled time limit.
7. The item of works contained in the schedule shall be executed strictly accordingly to the specification prescribed in CMDA ,PWD schedule and the workmanship may be inspected by the competent authority and the contractor shall be liable to make necessary arrangement of facilities such inspection if required final payment on receipt of the certificate from the competent authority.
8. The work shall have to be completed in all respect within the time limit as mentioned against it and such time limit shall be treated as essence of the contract.
