Tenders in Sealed Cover addressing to the Chairman Hooghly Chinsurah Municipality are to be submitted at the Tender Box which is kept in the chamber of Head Clerk within 2p.m. on 21/05/2018 positively & tenders may be opened between 3.30 to 4p.m. on same day. For any unavoidable administrative reasons, date & time of opening tender may be changed.
- 4. A tender is to quote in figure as well as in words his rated at per or with percentage below or above the estimated cost.
- 5. The tender documents should bear the signatures of the contractors, deposit of earnest money as specified below against the work in the form of Bank Draft drawn from any Nationalized Bank, Copy of GSTIN, Copy of PAN, Copy of Valid Trade Lincence and Credential of Rs. 1.00 Lakh of similar nature of works within last 3 years are to be enclosed with the Tender Paper.
