Sealed quotation are invited from the reliable and experienced contractors of Electrical work for supply of three Generators, 20 KVA, 10 KVA, 5 KVA to the Hooghly Chinsurah Municipal office on monthly hire system to be operated by his own operator for office purpose between power supply interruption from West Bengal State Electricity Distribution Company Ltd. ( W B S E D C L ).
2. All quotations in sealed cover, address to the Chairman, Hooghly Chinsurah Municipality Superscribed with the wards, " QUOTATION FOR SUPPLY OF GENERATORS ON HIRE SYSTEM" will be dropped in the tender box in the office of the undersigned with in 2 P M on the dated 12/10/2018.
3. None need apply who has not gathered any credentials for this electrical job/works. An earnest money of Rs. 2000/- ( Rupees two thousand only) is to be deposited in cash and necessary records & credentials there of should be accompanied with the quotation will liable to be rejected if earnest money is not deposited before the quotation is dropped.
4. The intending quotations may inspect the existing system of electrical wiring, no of lights, fans and plug point for which A.E will help them. All other terms and conditions may be seen from this office.

### SCHEDULE OF WORKING HOURS OF GENERATORS

5. One 20 KVA, one 10 KVA and one 5 KVA generator will work for feeding power during office hours on account of load shedding interruption of power supply from WBSEDCL as per particulars noted below :-
  - A. All working days beginning from 10-00 a.m. to 5-00 p.m. working hours may be extended by 1 or 2 hours every working days.

6. Second generator 10 KVA and third 5 KVA generator will work for feeding power not only during office hours but also beyond office hours as per particulars noted below :-

A. All working days beginning from 10-00 a.m. to 5-00 p.m.

B. After closer of the office (i.e 5-00 p.m.) these 2<sup>nd</sup> and 3<sup>rd</sup> generators will be supply even upto 10-00 p.m. if situation arised due to interruption of power of load shedding of WBSEDCL Supply such longer service upto 11-00 p.m. by the 2<sup>nd</sup> 10 KVA & 3<sup>rd</sup> i.e.5 KVA generator will be operated for fans and lighting arrangement to the departments such as main office in ground floor, A.C Meeting Hall, Cash room, Auditorium on the first floor, Darwan room, total office compound and also some of the departments as and when are to be required.

If required generator work beyond 10-00 p.m. for lighting arrangement within office compound will be continue till power is restored to further for Sunday and Holidays, Schedule work at light will continue specially for lighting arrangement within office compound, Darwans room, & other place when required.


7. The Contractor shall be liable to provide fuel and reliable & sincer skill operator at his own expenses for smoothly operating three generators as per working schedule noted above and the must over come and alert about their responsibilities to operate with all premises whenever interruption of power takes place due to load shedding or any other fault are to be secured.

8. The quoters are to quote their rate per month for three generators as mentioned in sl.no. 5 and sl.no. 6 of which schedule working hours of 2<sup>nd</sup> & 3<sup>rd</sup> generators are longer than 1<sup>st</sup> generator.

The undersigned is not bound to accepted the lowest rate or any other rate and in this decision in the matter of acceptance of quotation will be final and binding upon the contractor.

The accepted rate will remain valid for three years from the date of issue of work order.

The successful quoter will have to execute an agreement with the municipality at his own cost containing terms and conditions which will valid for three years and will be deposit to the extent of Rs. 10,000/- ( Rupees ten thousand only ) inclusive of earnest money of Rs. 2000/- (Rupees Two thousand only) as a security money.


